Our adventures are varied and tailor made exclusively for each booking; from exploring by helicopter and fishing vast lakes, to trekking on foot, horse or camel with mobile camps into the unknown. Ol Malo Nomad also offers guests the opportunity to get more involved and support the Samburu eco-system through the Samburu Trust by walking with the Samburu people to secure their land, its wildlife and their shared future.

Using their helicopter, a team of camels, sure-footed horses and ancient tribal knowledge, adventure is at your finger tips. TWO3TWO is a 7-night safari for the ultimate Nomad.

RATES IN US DOLLARS PER PERSON PER NIGHT

Included: Full board accommodation in mobile fly camp, horse back or walking safaris supported by camels, conservancy fees, soft drinks, local beers, non-premium wines and spirits, limited laundry, Ol Malo airstrip transfers, activities as shown and statutory taxes.

Maximum number of people for riding safari is 4 (WEIGHT LIMIT - 85KG. Experienced riders only).

Maximum number of people for walking safari is 6.

Excluded: Champagne, premium spirits, cellar wines, transfers to / from Loisaba Airstrip - US\$ 58 per transfer, Helicopter flights (for up to three passengers in each helicopter subject to passenger weights). Cost is EXTRA and dependant on itinerary chosen and flying time.

CHOPPER: Helicopter excursions to far out areas of Kenya, designed for photographers, adventurers and fishing enthusiasts. A fly-camping safari, on horseback or on foot supported by camels from Ol Malo

HORSE: A private horseback safari supported by camels. The helicopter can be used to drop off and collect guests (extra cost). Maximum 4 people and minimum 2 people

WALK: A private walking safari supported by camels. Maximum 6 people and minimum 2 people

Private charters to Ol Malo Airstrip
By road - Approx. 6Hrs drive from Nairobi

Terms & Conditions 2022

(Central Reservations)

① Bookings are accepted on the condition that guests have their own comprehensive Travel Insurance to cover all eventualities, including cancellation for any reason.

② Bookings are confirmed upon receipt of a 20% REFUNDABLE deposit; (refundable net of finance charges up to 46 days before arrival).

③ The balance is payable in full by 45 days before arrival.

④ **To place a provisional booking:** Please send an email to bookings@bush-and-beyond.com. Your booking will be held provisionally for 14 days. The expiry date of the booking will be noted on the reservation summary that you are sent. You are required to confirm the booking prior to the expiry date otherwise it will automatically expire. If you require more time to confirm your booking, the expiry date may be extended once (on request).

⑤ **To confirm a booking:**

A booking shall only be confirmed upon receipt of a booking voucher and proof of Comprehensive Travel Insurance including "Cancel for any Reason" clause.

Please ensure that the booking voucher contains the following information:

- Type of room you would like to book
- Date, time and method of guests arrival and departure
- Number of people in the group and rooming requirements
- Names of ALL guests in the group and ages (especially of children)
- Any special dietary requirements or other special requests

⑥ **In the event of cancellation:**

Between 45-31 days 50% of the full payment will be forfeited. 50% will be refunded. Cancellations within 30 days of arrival forfeit the full payment. (Except if travel is prevented by Government or Pandemic related travel restrictions, either to Kenya, or from the guest's home country.)
